

Contest and Rules

Eligibility:

Winner must be able to read and speak the English language.

Minors must have the consent of a parent or legal guardian in order to be eligible to receive any prizes. Proof of guardianship may be required. Minor must have guardian in attendance during all recording sessions.

Prize is transferable one time to another eligible individual.

One Entry per person.

Contest Period:

Contest begins April 24, 2008. Last day to enter is June 30, 2008. Drawing will take place on or around July 11, 2008.

Binding Agreement:

In order to enter the Contest, you must agree to these Official Rules ("Rules"). Therefore, please read these Rules prior to Entry to ensure you understand and agree. You agree that submission of an Entry in the Contest constitutes agreement to these Rules. You may not submit an Entry to the Contest and are not eligible to receive the prizes described in these Rules unless you agree to these Rules. These Rules form a binding legal agreement between you and The Henry and Buster Show with respect to the Contest.

Judging:

Decisions of The Henry and Buster Show and the Judges are final and binding on all matters pertaining to this Contest.

Prize Distribution & Redemption:

Identification must be produced on request.

The prize is not redeemable in cash and must be accepted as awarded. Decisions of the Contest judges are final - no substitutions will be available.

Any potential winner who cannot be contacted by phone or email within 15 days of attempted first notification will forfeit his/her prize.

Recording location for Win a Voiceover Role is held at Curbside Productions Studio in Minneapolis. Phone-in recording will be made available if necessary. Alternate on-site recording location is at the discretion of The Henry and Buster Show. All transportation to/from the recording studio must be provided by the prize claimant. Script will be provided to the winner in advance. Claimant has the right to refuse the role written for him/her but no substitution will be provided.

Privacy:

Participants agree that personal data including, but not limited to, name, mailing address, phone number, and email address may be collected, processed, stored and otherwise used for the purposes of conducting and administering the Contest. This data may be transferred into the United States. Further, this data may also be used by The Henry and Buster Show to verify a Participant's identity, postal address and telephone number in the event a Participant qualifies for any applicable prize as well as to deliver the applicable prize(s).
